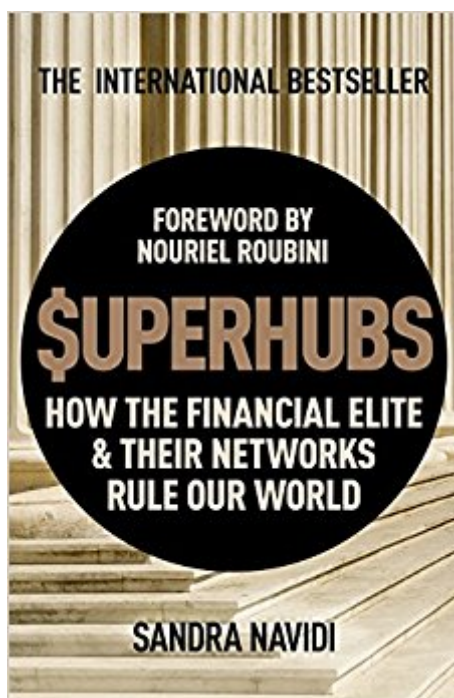

Sandra Navidi is the Founder and CEO of BeyondGlobal, a consulting firm, where she renders macroeconomic and strategic positioning advice. Previously, Ms. Navidi worked closely with economist Nouriel Roubini as Director of Research Strategies and Senior Relationship Manager at Roubini Global Economics. Prior to that Ms. Navidi had positions as investment banker at Scarsdale Equities, general counsel at Muzinich & Co. and consultant at Deloitte. Ms. Navidi holds a law degree from the University of Cologne School of Law, Germany, and a Master-of-Law Degree in Banking Corporate and Finance law from Fordham University School of Law, USA. She is admitted to practice law in the Federal Republic of Germany as well as in the State of New York. As an expert commentator on financial markets, Ms. Navidi has given over 600 interviews on international media outlets and has keynoted at dozens of large industry events.

If you want to know what it's like being a fly on the wall in Davos at the World Economic Forum and similar events, how denizens of high-altitude gatherings operate, this is an interesting book. Global leaders at the pinnacle of society spend much of their energy trading information, ideas, social capital, loyalty in their networks, and constantly trying to expand them, flitting from Davos to central bank meetings to charity boards and galas and the Hamptons. The definitive academic sociological and quantitative study of these networks, their evolution and influence hasn't been written, but this is a highly entertaining and readable portrait.

It was my good fortune to become acquainted with Ms. Navidi and her outstanding book on the global financial world and its elite players by seeing her as a guest on C-Span's Q & A with Brian Lamb. While the majority of books written about the global financial world and its key players are written in a somewhat dry, academic format, this book takes the reader on a journey through the world of the ultra-rich players in more of a narrative style by citing her personal experiences with these players. In terms of interest, I had a difficult time putting this book down; I typically spent two to three hours each day reading it until completion. Furthermore, "SUPERHUBS" is so thought provoking, I fully intend to continue to study Ms. Navidi's outstanding book in the future. The most vital reason for a person to read "SUPERHUBS" is to gain a deep insight into the world of immense wealth and power that super rich

financial leaders possess, and to more clearly comprehend how their social networks influence the world's political climate, lawmakers' decision-making, and the overall economic environment of the world in which we live. While I could delve into additional details regarding each chapter, I choose not to do so in this review; I can only highly encourage everyone to read this book in order to become a better-informed voter and citizen. As a longtime reader of politics and economics, I have never encountered a book that is filled with such a high degree of vital information; is written in such an elegant, to the point style; yet is accessible in better understanding the world of global finance and its elite players.

In her book *\$UPERHUBS* Ms. Sandra Navidi exposes the inner workings of the global financial system. At the center are super connected and influential individuals who pursue their interests. The financial system is one of the most important man made systems. It touches each of us in one way or another. One can't escape it. By pursuing their own interests the actions of a relatively few *\$UPERHUBS* affect the lives of many, and even the entire financial system. What is good for the *\$UPERHUBS* may not be good for the less well connected, less powerful, or even society as a whole. Somehow most readers will probably have suspected this to be the case. In her descriptive analysis Ms. Navidi provides us with details, names, true stories, and observations that only she can tell because she is so close to the *\$UPERHUBS*. Over the years Ms. Navidi has gained the trust and respect of the *\$UPERHUBS*. Naturally *\$UPERHUBS* have no interest in revealing the inner workings of their networks and the power they have. Ms. Navidi's book is skillfully written in a way that does not offend the *\$UPERHUBS* and still provides deep insights into their world. For those who spend their lives close to the *\$UPERHUBS* this book is a good source of reference. For those who spend their lives far away from any *\$UPERHUB* the book provides insights that no other book is able to deliver. Ms. Navidi's detailed, yet fluent writing style makes her book a pleasure to read.

Mrs. Navidi takes the cultural anthropologist approach of "participating observation" to the world of the global financial elite. As a "participant" and astute observer of human nature, gifted with a razor sharp analytical mind, she offers an insightful, well written perspective on what motivates this elite, the psychological make up of some of its most illustrious characters, and the way they network and interact. She refreshingly refrains from taking a moral position, leaving it up to the reader to decide if the protagonists of the story are super villains, super heroes, or simply highly intelligent alpha males with extreme appetites for acquiring power and \$\$\$\$. A highly recommended read for those with a

natural interests in culture and psychology, and an indispensable read for those that add to this an interest in global finance and economics.

The book details the mechanics of the power networks that run the global economy. Illustrative cases show how people became superhubs and what continues to keep them connected.
