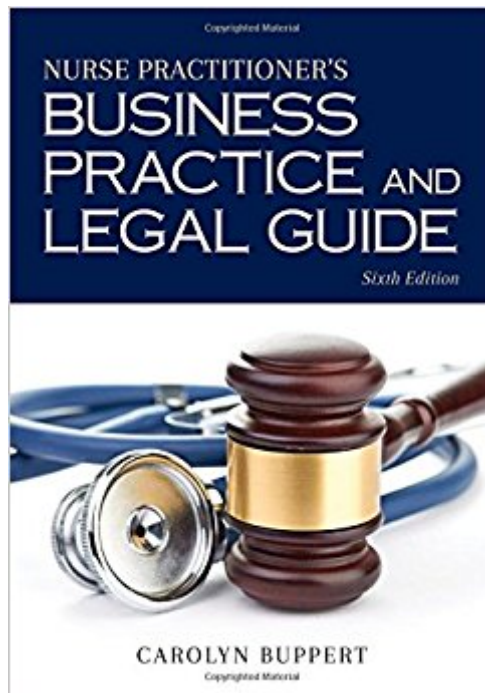

- \* Criminal cases against NPs who prescribed opioids or steroids either without authorization or without appropriate evaluation and monitoring
